

**IN THE CIRCUIT COURT OF JACKSON COUNTY, MISSOURI
MUNICIPAL DIVISION, GRANDVIEW, MISSOURI
ADMINISTRATIVE ORDER 2012-001**

Grandview Municipal Court by the authority of Supreme Court Rule 37.49 has an established Violation Bureau. This Violations Bureau allows defendants to dispose of their payable violations without a court appearance. Defendants may waive a trial, enter a plea of guilty and pay their fine and costs through the mail, on-line or at the clerk's office without making a court appearance. Any violations resulting in property damage, injury, an accident or involving drugs or alcohol requires a court appearance.

The violations listed below in the fee schedule may be disposed of through the Violations Bureau with the fines and costs paid in full based on the amount shown:
