The City Clerk, or designated representative, of the City of Grandview, Missouri, will receive sealed bids for the **TAILS & TRAILS BRIDGE OVER LITTLE BLUE RIVER – PHASE 2** project until 10:00 A.M., on the 6<sup>th</sup> day of March, 2018, at the Municipal Services Building, 1200 Main Street, Grandview, Missouri 64030, at which time all bids received will be publicly opened and read aloud.

The contract provides for: Repairs, reconstruction and erection of the steel tied-arch bridge components that were relocated adjacent to the Tails & Trails Dog Park in Phase 1. The contract also includes construction of new abutments, grading and trail connections on each side of the Little Blue River.

An optional prebid meeting will be held at the Municipal Services Building, 1200 Main Street, Grandview, Missouri 64030 at 10:00 A.M., on the 22<sup>nd</sup> day of February, 2018.

Bidding documents will be shipped only if the requesting party assumes responsibility for all related charges. Corporate, certified, or cashier’s checks shall be made payable to Drexel Technologies, Inc.

Interpretations will be made only by addendum, duly issued, and one copy of any such addendum will be emailed to each party who has received sets of these contract documents for the purpose of bidding. Because of the time required to publish and deliver, no interpretative addendum will be issued within the last five (5) days before the bid date.

This advertisement is for qualified contractors, experienced in the construction of public improvements. Bids from construction managers that intend to hire the construction of the project will not be considered as responsive to the proposal. The successful bidder will be required to provide proof of either ownership or lease of equipment that will be utilized to construct this project.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher. The project is subject to the requirements of RSMo 292.675 concerning worker safety. Pursuant to RSMo 285.530 bidders are required to submit, or have on file with the City of Grandview, the Worker Eligibility Verification affidavit within the contract documents.

The City of Grandview hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

Section 102.2 of the Missouri Standard Specifications for Highway Construction will be waived for this project. The DBE Goal for this project is 7.0%. A certified or cashier’s check of a bid bond in the amount of 5% shall be submitted with each proposal. No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
