CITY OF GRANDVIEW, MISSOURI INVITATION FOR BID

Sealed bids for Exclusive Solid Waste Permit services, under provisions of Section 23-61 of the City of Grandview Code of Laws, will be received by the City Clerk at the Municipal Services Building, 1200 Main Street, Grandview, Missouri 64030. Bid shall remain valid for sixty (60) days from the date of bid opening. **To be eligible to submit a bid for this work, every bidder must be in possession of a current City Solid Waste Hauling Permit.**

The winning bidder for this work shall be issued an exclusive permit on an annual basis (July 1 – June 30), except that the City may extend the exclusive permit for two (2) successive, one (1) year extensions for a total maximum contract length up to three (3) years. **For the first contract period, the contract will run from January 1, 2019 through June 30, 2019. Each of the next two (2), one (1) year extensions shall run from July 1 – June 30.** Sealed bids shall be marked with the words “Belvidere Special Solid Waste Area Bid” on the outside of the envelope.

Bid Period

Sealed bids will be received, by the City Clerk as prescribed above, until **Tuesday, November 20, 2018 at 10:00AM** at which time the bids will be opened and read aloud publicly. Late bids will not be opened and will be returned unopened.

Area of Service

The area of service is bounded by the centerlines of East 151st Street, Bellaire Avenue, East 155th Street and Barat Avenue in the City of Grandview, Missouri. The 52-unit Belvidere Square Apartments is not to be serviced under this exclusive permit. There are an estimated 438 dwelling units to be served under this permit. Included with this Invitation to Bid is a map showing the Service Area.

Level of Service

The following services shall be provided by the exclusive permit holder:

1. Regular weekly pick-up (1 time per week) of garbage and trash, **which shall be accomplished on a single day**, from all dwelling units in accordance with Article IV of Chapter 23 of the Grandview Code of Laws entitled “Solid Waste Collection and Disposal”. Trash containers to be picked up shall be within 12 feet of the back of the curb and shall include adjacent bags of trash.
2. Regular weekly pick-up (1 time per week) of non-hazardous large household items not picked up under item (1) above. Large items to be picked up shall be within 12 feet of the back of the curb.



3. Provision of 90 gallon solid waste containers on wheels with attached tight fitting lids adequate to serve the dwelling units within the Belvidere Special Solid Waster Service Area and clearly marked with the address of the dwelling unit being served.
