

**IN THE CIRCUIT COURT OF JACKSON COUNTY, MISSOURI
GRANDVIEW MUNICIPAL DIVISION
ADMINISTRATIVE ORDER 2012-001**

Grandview Municipal Court by the authority of Supreme Court Rule 37.49 has an established Violation Bureau. This Violation Bureau allows defendants to dispose of certain payable violations without a court appearance. Defendants may waive a trial, enter a plea of guilty, pay their fine and costs at the clerk's office, by mail or on-line without making a court appearance. Violation(s) resulting in property damage, injury, accident, drugs or alcohol, or any other pre-defined offense(s) requires a court appearance. The violations listed below in the fee schedule may be disposed of through the Violation Bureau pursuant to SCR 37.495 with the fines and costs paid in full based on the amount shown:

If you fail to respond to a moving violation by prepayment, by appearing in court and/or by paying the fine and court cost as defined by administrative order within the time allowed, other legal penalties prescribed by law may be imposed.

Fines and costs are subject to change without advance notice. These fines and costs were in effect as of January 05, 2012 and updated on the following dates: August 28, 2013, September 10, 2015, April 13, 2016, August 28, 2016, April 27, 2018, May 1, 2019 and shall be in effect until changed by law and/or Administrative Order.
