It is required that your firm's Statement of Qualification (RSMo 8.285 through 8.291) be submitted with your firm's Letter of Interest. The statement of qualification is not included in the total page count limit.

Disadvantaged Business Enterprise (DBE) firms must be listed in the MRCC DBE Directory located on MoDOT's website at [www.modot.gov](http://www.modot.gov), in order to be counted as participation towards an established DBE Goal. We encourage DBE firms to submit letters of interest as prime consultants for any project they feel can be managed by their firm.

It is required that your firm be prequalified with MoDOT and listed in [MoDOT's Approved Consultant Prequalification List](#), or your firm will be considered non-responsive.

If your firm would like to be considered for these consulting services, you may express your interest by submitting proposals (three hard copies and one flash drive with pdf file) to the attention of Jackie White-Public Works Department, City of Grandview, 1200 Main Street, Grandview, Missouri 64030, not later than **3:00 PM Friday, August 9, 2019**. Consultant Services Required:	<p>Services require knowledge of state and local roadway and pedestrian design and construction oversight requirements.</p> <p><u>Design Services:</u> Preliminary and final design plans for roadway and pedestrian improvements within the project limits. Requires expertise and knowledge in temporary and permanent traffic control design, turn lane design, signal design, signing, striping, lighting, storm water management and infrastructure design, pavement design, traffic management, and non-motorized transportation design criteria. Field and design survey work and utility relocation may also be required.</p> <p><u>Construction Services:</u> Document and ensure design compliance of roadway and related construction of improvements including turn lane installation, signal installation, temporary and permanent roadway signing and striping, drainage feature construction, pedestrian improvements, and related project features on behalf of the City and MoDOT. Services may include onsite inspection, materials testing, construction materials approval, shop drawing review and approval, monitoring of construction staking and surveying, oversight of construction operations including utility relocation, field inspections and reporting, conducting wage rate and Commercial Useful Function interviews, preparation of pay estimates, and participating in final inspection and project close out documentation.</p>
