1. DELIVERY HOURS  
Delivery of product shall be made in accordance with the times and dates stated in this solicitation or within a reasonable mutually agreed upon period of time as determined by the Director of Public Works or a designee. Normal delivery hours shall be between 7:00 a.m. to 3:30 p.m. Monday through Friday at 7000 E. 139<sup>th</sup> St., Grandview, MO, but special delivery hours can be arranged. 2. SUBCONTRACTS AND NON-ASSIGNMENT  
Neither this contract, nor any portion thereof, shall be sublet except with the written consent of the Director of Public Works. No such consent shall be construed as making Grandview a party to such sub-contract, or subjecting Grandview to liability or any kind to any sub-contractor. No sub-contract shall under any circumstances, relieve the contractor of any liability and obligations under this contract, and all transactions with Grandview, acting through the Director of Public Works, must be through the General Contractor.

  - 2.2 Ability to deliver product in accordance with the dates and times specified herein.
  - 2.3 Bidder's ability to meet all specifications, terms and conditions of bid.
  - 2.4 All other criteria as specified in this bid.
